OBJECTOR'S PETITION

INTRODUCTION

Ryan Grace, hereinafter sometimes referred to as the "Objector", states as follows:

- 1. The Objector resides at 8303 44th Street in the Village of Lyons, State of Illinois, 60534, and is a duly qualified, legal and registered voter at that address.
- 2. The Objector's interest in filing this Petition is that of a voter desirous that the laws governing the filing of nomination papers for the office of Village President in the Village of Lyons, ("Office") are properly complied with, and that only qualified candidates appear on the ballot for said office.

OBJECTIONS

- 3. The Objector makes the following objections to the purported nomination papers ("Nomination Papers") of James K. Jenks, a candidate for Village President in the Village of Lyons, to be voted at the Consolidated Election on April 4, 2017 ("Election"). The Objector states that the Nomination Papers are insufficient in fact and law for the following reasons:
- 4. Pursuant to state law, nomination papers for Village President in the Village of Lyons, Cook County, to be voted for at the Consolidated Election on April 4,2017, must contain the signatures of not fewer than 68 duly qualified, registered and legal voters of said district collected in the manner prescribed by law. In addition, said Nomination Papers must truthfully allege the qualifications of the candidate, be gathered and presented in the manner provided for in the Illinois Election Code, and otherwise executed in the form provided by law.
- 5. The Statement of Candidacy is invalid and perjurious since the Candidate was not a resident at the address listed on the Statement of Candidacy for the required amount of time pursuant to law in order to qualify as a candidate for Village President in the Village of Lyons. Although registered to vote at the address in Lyons, the Candidate, upon information and belief,

was not a resident at that address and has not been a resident of the Village of Lyons for the time required by law.

- 6. The Statement of Candidacy is invalid since the Candidate is not legally qualified to hold the office of Village President, and was not qualified at the time of signing his Statement of Candidacy because of the reasons stated above. Upon information and belief, the Candidate was a resident at 4363 N. Kenmore Ave. #101 in Chicago Illinois, 60613 at least up to and including June 16, 2016. See Attached Exhibit A.
- 7. The Nomination Papers contain the names of persons who did not sign said papers in their own proper persons, and said signatures are not genuine and are forgeries, as is set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading, Column A. "Signature not genuine signature of purported voter", in violation of the Illinois Election Code.
- 8. The Nomination Papers contain petition sheets with the names of persons who are not properly registered voters at the addresses shown opposite their respective names, as is set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading, Column B. "Signer not registered at address shown within political district", in violation of the Illinois Election Code.
- 9. The Nomination Papers contain petitions sheets with the names of persons for whom the addresses given are either missing entirely or are incomplete, as is set forth specifically in the Appendix-Recapitulation attached hereto and incorporated herein, under the heading, Column D. "Signer's address missing or incomplete", in violation of the Illinois Election Code.
- 10. The Nomination Papers contain the names of persons who have signed the Nomination Papers more than one time as is set forth specifically in the Objection and Appendix-Recapitulation Sheet attached hereto and incorporated herein, under the heading, Column E, "Signer signed more than once at sheet/line indicated", in violation of the Illinois Election Code.
- 11. The Nomination Papers contain sheets circulated by James K. Jenks, Ryan Lukas, and Amanda Brost, whose sheets demonstrates a pattern of fraud and disregard of the Election Code to such a degree that every sheet circulated by said circulators are invalid, and should be invalidated in order to protect the integrity of the electoral process. Such circulators are those who circulated the sheets in which objections are made in Column A of the Objection and Appendix-Recapitulation Sheet.
- 12. Petition sheets numbers 1, 3, and 8 contain a circulator's oath where the circulator purports to reside at 3806 Sunnyside Ave., Brookfield, IL 60513. However, upon information and belief the Circulator Ryan Lukas resides at 3623 Forest Ave., Brookfield, IL 60513. See Attached Exhibit B or somewhere other than the address in the Circulator's Affidavit. Each and every one of these circulators oaths on these 3 petition sheets is false and perjurious and these sheets must be stricken in their entirety. Further, as to the circulator who purportedly circulated

the sheets, it constitutes a pattern of fraud.

- 13. Upon information and belief, that Circulator James K. Jenks does not live or reside at 8033 42nd Ct., Lyons, and his circulator affidavit is false invalidating sheets 2 and 7 of the petition sheets.
- 14. The Nomination Papers contain petition sheets with signatures which are insufficient and improper since the signer previously signed the petitions of another Candidate, as set forth specifically in the Objection and Appendix-Recapitulation attached hereto and incorporated herein under the heading Column G "Signer previously signed another Candidate's nomination petition", in violation of the Illinois Election Code.
- 15. The Nomination Papers contain less than 68 validly collected signatures of qualified and duly registered legal voters of the Village of Lyons, Cook County, Illinois, signed by such voters in their own proper person with proper addresses, below the number required under Illinois law, as is set forth by the objections recorded in the Appendix-Recapitulation attached hereto and incorporated herein.
- 16. The Appendix-Recapitulation is incorporated herein and the objections made therein are a part of this Objector's Petition. The headings in the Appendix-Recapitulation in Columns a.-g. are specific objections.
- 17. The Nomination Papers contain petition sheets with the names of persons who for whom addresses are stated which are not in the Candidate's District and such signatures are not valid, as is set forth specifically in the Objection and Appendix-Recapitulation Sheet attached hereto and incorporated herein, under the heading Column C, "Signer resides outside district", in violation of the Illinois Election Code.

CONCLUSION

WHEREFORE, the Objector requests a hearing on the objections set forth herein, an examination by the aforesaid Electoral Board of the official records relating to voters in the applicable district, to the extent that such examination is pertinent to any of the matters alleged herein, a ruling that the Nomination Papers are insufficient in law and fact, and a ruling that the name of James K. Jenks shall not appear and not be printed on the ballot for election to the office of Village President in the Village of Lyons, to be voted at the Consolidated Election on April 4, 2017.
