

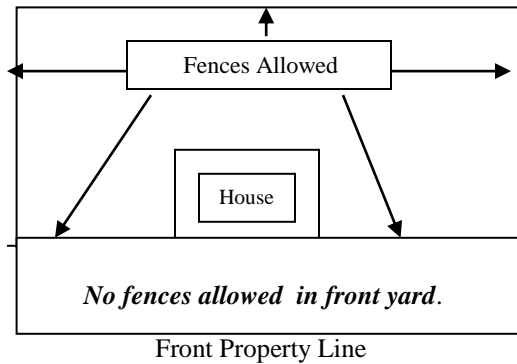

Fence Construction Specifications

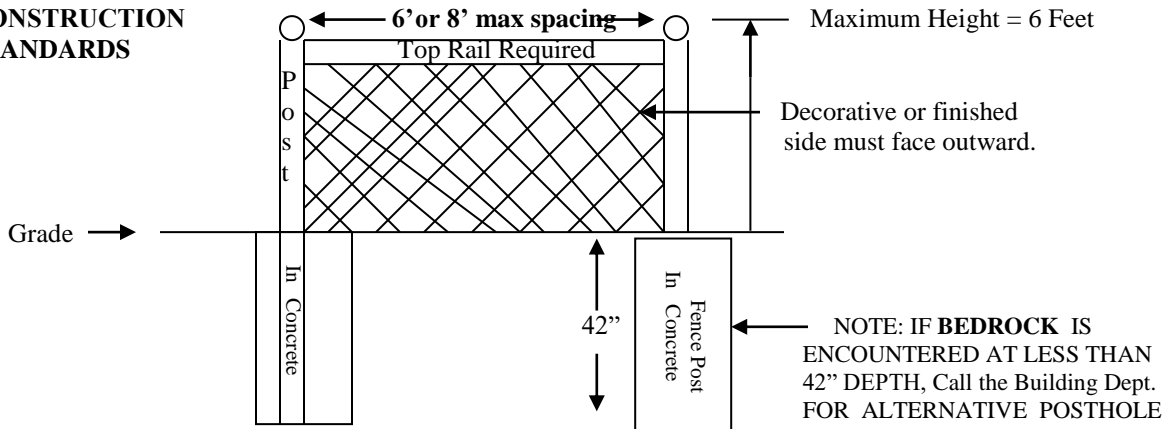
LOCATION

Fences are allowed in Side and rear yards only.

Front yard fences are not allowed. The front fence may not extend past the front of the house.



CONSTRUCTION STANDARDS



OTHER STANDARDS

1. There may be no more than one perimeter fence per property line.
2. Fences must be architecturally compatible with the neighborhood.
3. Fences may not be constructed so as to create a traffic or pedestrian hazard.
4. Fences may not be erected so as to encroach on other property.
A Plat of Survey is required to avoid encroachment.
5. Barbed or razor wire, etc., is not allowed in residential areas.
6. Dog runs are required to be a minimum of 8 feet from side and rear property lines, and, Twenty-five (25) feet from neighboring houses.

PERMITS Fee: \$50.00

1. A permit must be obtained prior to beginning fence construction. A permit application must be completed and submitted to the Building Department, along with a copy of a **PLAT OF SURVEY** for the property. Please draw all existing and proposed fence locations and dimensions on the copy of the Survey.
2. Normal turnaround time for fence permits is 2 business days. Do not schedule or allow installation until the permit has been issued. Verify permit issuance with the Building Department.
3. It is recommended that you not pay the contractor in full until you have verified inspection approval with the Building Department at (708) 442-4500.
